Electronic Funds Transfer (EFT) Authorization

Electronic Funds Transfer (EFT) service allows you to authorize Evergreen Family Friendship Service to have your monthly gift to Evergreen transferred directly from your bank account to ours, without having to write a check.

Here's how to get started!

- 1. Complete the form below (it is important that you provide us with all of the requested information).
- 2. Read the terms on the back of the form, and then sign and date the form.
- 3. Return this form with your monthly contribution check (or a voided blank check) from your personal checking account or a deposit slip from your savings account (whichever account you want the money transferred from). Please mail the form to us at the above address.

The first automated transfer will occur in about six weeks. You will receive a letter confirming that Evergreen has enrolled you in this plan and the date of your first EFT transaction.

A record of each of the EFT transactions will show on your monthly bank statement, and you will continue to receive a receipt from Evergreen each month. This arrangement for making your contribution to Evergreen Family Friendship Service will remain in effect until you let us know that you want it to stop. You can stop or change your monthly EFT at any time.
